4. In regard to the staff being drafted randomly from other constituencies covering Central Government/State Government/Banks/Insurance employees etc., specific instructions have been issued vide G.O.Ms.No.543 GA(Elec.C)Dept., dated 9.12.2005 shall be followed.

5. The Secretary State Election Commission shall take necessary action accordingly.
