In the circumstances reported by the Commissioner & Director of School Education, Hyderabad, and after careful examination of the matter in the light of the Judgment 5th read above, Government hereby accord **permission for approval** of (36) cases of selections to fill up vacant aided posts and (9) cases of absorptions from unaided posts to Aided posts, as indicated in the Annexure to this G.O., by the competent authority in terms of the rules framed in G.O.1st read above, where the process of recruitment had already been commenced **prior to ban** in Aided schools, pursuant to the **initial permission** granted.

3. The Commissioner & Director of School Education, Hyderabad, shall take necessary action accordingly in the matter.
