**ORDER:**

In the G.O. 1<sup>st</sup> read above, Government have issued orders declaring 05.10.2014 (Sunday) as Public Holiday on the occasion of Bakrid under Negotiable Instrument Act 1881.

2. On the representations received by the Government, vide letters 2<sup>nd</sup> and 3<sup>rd</sup> read above, for declaring General/Public holiday on 06.10.2014, the Chief Executive Officer, Andhra Pradesh State Wakf Board, has been consulted, in the reference 4th read above.

3. In his letter 5<sup>th</sup> read above, the Chief Executive Officer, Andhra Pradesh State Wakf Board, Hyderabad has recommended to declare 06.10.2014 (Monday) instead of 05.10.2014 (Sunday) as General/ Public Holiday on the occasion of Bakrid as per moon sight.

4. The Government, after careful consideration of the matter, have decided to change the Public Holiday from 05.10.2014 (Sunday) to 06.10.2014 (Monday) on the occasion of Bakrid. Accordingly, the following notification is issued and shall be published in the extra-ordinary Gazette of Andhra Pradesh:

In partial modification of the orders issued in G.O.Rt.No.5237, General Administration (Poll.A) Department, dated 29.11.2013, notifying the Holidays under Negotiable Instrument Act 1881 for the year of 2014, the Government hereby on the occasion of Bakrid in addition to Sunday on 05.10.2014, defined as Public Holiday in the said "Explanation" hereby notify on 06.10.2014 (Monday) to be observed as a Public Holiday in Andhra Pradesh during the year 2014.
